The Special Meeting was called to discuss Fire Department construction improvement projects. The press was properly notified.

Richard Pontius of RP Hughes Architects, Inc. presented a letter dated August 15, 2007 and a preliminary estimate of construction costs for Fire Sta. 131, Sta. 133, Sta. 134 and 485 Rocky Fork Blvd. (annex) at a cost of \$2.9 million. (See Referral File)

Mr. Pontius explained the preliminary architectural/engineering fees contract to begin drawings, etc. (formal building program). He discussed both construction costs and contingencies with the Board.

Financing of the project was also discussed. The Fiscal Officer will look into some options. The Trustees agreed that they wanted to continue the continuity of architectural services by using RP Hughes Architects, Inc. who has done our previous projects.

The Trustees agreed to approve the Contracts with Bird & Bull to perform site engineering surveys for Sta. 133, Sta. 131 and 485 Rocky Fork Blvd. as recommended by Richard Pontius.

## Res. 222-07: Approve Contracts with Bird & Bull to Perform Site Engineering Surveys for Sta. 133 for \$5800 and Sta. 131 & 485 Rocky Fork Blvd. for \$5500

Mr. Spanovich moved to approve the contracts with Bird & Bull for site engineering surveys who we have worked with in the past for Sta. 133 for \$5800 and Sta. 131 & 485 Rocky Fork Blvd. for \$5500 as proposed. Mr. Angelou seconded. All voted yea. Motion carried. (See Referral File)

Chief DeConnick said that no building improvements for Fire Sta. 132 are planned at this time due to the age of that station. The Chief did say that he was approached by someone offering to include Fire Sta. 132 as part of a project being considered at Innis & Westerville which would be similar to that of Violet Township.
