*Only items in a tightly sealed container will be taken.

Flammables:

- Lighter Fluid
- Turpentine
- Kerosene
- Oil Based Paint
- Thinners
- Polishes
- Propane tanks 20 lbs
- Old Oil
- Vehicle Batteries
- Old Gasoline Mixed with Oil
- Adhesives
- Old Gasoline

Reactives:

- Cyanides
- Pool Chemicals
- Strong Chemicals

Corrosives:

- Acids & Caustic
- Drain Cleaners
- Paint Strippers
- Bleach & Household Cleaners

Toxics:

- All Fluorescent Light Bulbs
- Lawn Chemicals & Fertilizers
- Lithium Batteries
- Car Vehicle Batteries
- Fire Extinguishers
- Rat Poison
- Regular Batteries
- Antifreeze
- Insecticides
- Mercury / Ni-Cad batteries

Others:

- Fats, Oils and Grease
- Latex/water base paint (**ONLY accepted at permanent site**, with a disposal fee of \$1.00 per can of latex paint from 1 quart to 5 gallons; **NOT accepted at mobile sites**)

WHAT IS NOT ACCEPTED AT THESE SITES

- Appliances
- Computers
- Asbestos
- Propane Tanks (over 20 lbs.)
- Tires
- Ammunition
- Needles & Medical Waste
